- 5. Sealed bids must be submitted to the Ramechhap Municipality, Office of the Municipal Executive, Ramechhap Bazar, Ramechhap by hand before 12:00 Noon on 2076/11/30. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend after 14:00 PM 2076/11/30, Ramechhap Municipality, Office of the Municipal Executive, Ramechhap Bazar, Ramechhap. Bids must be valid for a period as indicated in table above from counting from the days of bid opening and must be accompanied by a bid security, the amount and validity period as given in above table.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
