The bids will be opened in the presence of Bidders' representatives who choose to attend after 14:00 PM 2076/12/23 at Ramechhap Municipality, Office of the Municipal Executive, Ramechhapbazar, Ramechhap. Bids must be valid for a period as indicated in table above from counting from the days of bid opening and must be accompanied by a bid security, the amount and validity period as given in above table.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
