## Invitation for Bids for the Construction of Municipality Office Building

- Ramechhap Municipality has allocated funds towards the cost of Construction of Municipality Office Building
  and intends to apply the funds to cover eligible payments under the Contract and is open to all eligible Nepalese
  biddders.
- Ramechhap Municipality invites electronic bids from eligible bidders for the construction of *Municipality Building* under National Competitive Bidding Single Stage Two Envelope Bidding procedures.
   Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 3,55,20,000.00
  - Minimum Work experience of similar size and nature: 2 number of Project each of NRs. 1,89,50,000.00
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- Bidder to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document Rs 5000 in Rastiya Banijya Bank,Ramechhap Bazar, Ramechhap with Account No.1020304013101.
- 6. Pre-bid meeting shall be held at office of *Ramechhap Municipality*, *Ramechhap Bazar*, *Ramechhap* at 10:00 am on 20 oct 2019.
- Electronic bids must be submitted to the office Ramechhap Municipality, Ramechhap Bazar, Ramechhap by through PPMO's e-GP system <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12:00 noon on 01 Nov 2019. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs on 01 Nov 2019 at the office of Ramechhap Municipality. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Rs.6,00,000.00 which shall be valid for 30 days beyond the validity period of the bid with Account no.: 1020303003001.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
