## Invitation for Bids for procurement of Fabricated Steel Parts for Trail Bridges

#### First Date of Publication: 2076/08/26 (12/12/2019)

- 1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to Ramechhap Municipality for **Trail Bridge Program** and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
- 2. The Ramechhap Municipality invites sealed bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
- 3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted in nepaltrailbridges.org.np may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
- 4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Ramechhap Municipality or www.bolpatra.gov.np.
- 5. Bidding documents may be purchased from Ramechhap Municipality, office of the municipal executive, Ramechhap bazar or www.bolpatra.gov.np by eligible Bidders, on submission of a written application along with the copy of a) company/firm registration certificate b) VAT and PAN registration form c) TAX clearance certificate valid for F/Y 2075/76 d) Power of Attorney, and upon payment of non-refundable fee ( Cost of bid documents) as mentioned in following table for the biding documents. The bidders who wants to submit hardcopy of bid can purchase the bid document before 15:00 P.M.on 2076/09/25.
- 6. Bids must be submitted to the office of Ramechhap Municipality, Ramechhap or through www.bolpatra.gov.np, on or before **12:00 noon** on **2076/09/26 (11/01/2020).** Documents received after this deadline shall not be accepted.
- Bids will be opened in the presence of Bidders' representatives who choose to attend at Ramechhap Municipality on 2076/09/26 (11/01/2020) at 2:00 P.M. Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security, amounting to a minimum of 2.5 % of the quoted Bid amount (inclusive of VAT), which shall be valid for 30 days beyond the bid validity period.
- 8. If bidder wishes to submit the Bid Security & Bid Cost in the form of cash, bidder has to deposit cash in following bank account and submit bank deposit voucher along with the bid.
